
The Board of Directors of Harris County Municipal Utility District No. 468 will hold a regular meeting on **Wednesday, June 7, 2023, at 11:30 a.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Guadalupe Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. District security matters, including Interlocal Agreement with Harris County for substation.
4. Garbage and recycling matters, including annual CPI increase.
5. Renewal of District's insurance policies.
6. Acclaim Energy Management Agreement, and authorize necessary action, if appropriate.
7. Financial and bookkeeping matters, including payment of bills and review of investments.
8. Tax assessment and collections matters, including:
 - a. payment of tax bills; and
 - b. delinquent tax collections and installment agreements.
9. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
10. Engineering matters, including:
 - a. authorize design of facilities;
 - b. approve plans and specifications and authorize advertisement for bids for District facilities;
 - c. Water Plant Booster Pump modifications;
 - d. receive update on construction of facilities to serve development in the District and approve pay estimates, time extensions, change orders and final acceptance, as appropriate, for construction of District facilities, including outfall repair along Cypress Creek; and
 - e. easements, deeds, plats, consents to encroachment, requests for service or utility commitment letters.
11. Maintenance of District facilities, including:
 - a. update on maintenance of Vintage Royale Detention Pond and Vintage Royale Amenity Pond, including proposals for maintenance;
 - b. update on maintenance of regional detention pond; and
 - c. review and approve annual budget for Lake Management Services, L.P.

 - ii. District Connectivity Phase I; and
 - d. irrigation and maintenance in Louetta Road and authorize appropriate action.

15. Operation of District facilities, billings, repairs, and maintenance, including:
 - a. water accountability;
 - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
 - c. amend Rate Order.
