
The Board of Directors of Harris County Municipal Utility District No. 468 will hold a regular meeting on **Wednesday, November 1, 2023, at 11:30 a.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Guadalupe Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Review Sales Tax Tracking Report.
4. District security matters.
5. Financial and bookkeeping matters, including:
 - a. payment of bills and review of investments;
 - b. conduct annual review of Investment Policy and adopt Resolution Regarding Annual Review of Investment Policy; and
 - c. review, revise, and adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions.
6. Approve Annual Report and authorize filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
7. Annual Review of Procedures for Continuing Disclosure Compliance.
8. Tax assessment and collections matters, including:
 - d. payment of tax bills; and
 - e. delinquent tax collections and installment agreements.
9. Engineering matters, including:
 - a. authorize design of facilities;
 - b. approve plans and specifications and authorize advertisement for bids for District facilities;
 - c. receive update on construction of facilities to serve development in the District and approve pay estimates, time extensions, change orders and final acceptance, as appropriate, for construction of District facilities, including Water Plant Booster Pump modifications; and
 - d. easements, deeds, plats, consents to encroachment, requests for service or utility commitment letters.

 - c. approve pay estimates, change orders and final acceptance as appropriate for construction of projects, including District Connectivity Phase I; and
 - d. irrigation and maintenance in Louetta Road and authorize appropriate action.

14. Operation of District facilities, billings, repairs, and maintenance, including:
 - a. water accountability;
 - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service; and
 - c. amend Rate Order.
